Please provide a copy of your separation document (DD Form 214) and separation under honorable conditions.

The Legion Act has changed eligibility requirements to at least one day of active duty between Dec. 7th, 1941 and a date to be determined. Separation must be under honorable conditions.

Membership rules were revised to accept veterans who have not served during a conflict period. If you have honorably served at least one day on active duty under Federal (USC) orders between December 7th, 1941 and now, you are eligible for membership. If you are the son of an eligible veteran and have not served on active duty, you may be eligible for the Sons of the American Legion.
